The Short Version

To enter the contest, you must register (as a group or individual) for Learning • Technology • Design by February 17, 2020, at 11:59 pm EST at <https://ltd.leadinglearning.com>, follow Leading Learning on at least one designated social channel (LinkedIn, Facebook, and Twitter), and tag #LTD2020 and #LearningBoosterKit in a post.

The Official Rules

REGISTRATION IS NECESSARY TO ENTER OR WIN.

1.
